ORDER

THIS CAUSE came before the Court on the Plaintiffs' Notice of Intention to Take Jurisdictional Discovery [ECF No. 81], filed December 30, 2019. Plaintiffs propose a schedule for the taking of jurisdictional discovery, starting some six months after they filed this lawsuit and prompted, it would appear, by the Court's instruction that they address the issue of jurisdictional discovery in the December 26, 2019 Order [ECF No. 80]. Accordingly, the parties shall adhere to the following schedule:

1. The Expedia Entities¹ and Booking Entities² have until **January 17, 2020** to serve objections, if any, to Plaintiffs' first set of requests for production of documents and Rule 30(b)(6) notices seeking testimony from corporate designees on topics relating to personal jurisdiction.
2. Plaintiffs have until **January 22, 2020** to contact Magistrate Judge Jonathan Goodman to make arrangements to appear at his next available discovery calendar

to address any objections by Defendants to Plaintiffs' first set of requests for production of documents and Rule 30(b)(6) notices.

3. The Expedia Entities and Booking Entities have until **January 30, 2020** to respond to Plaintiffs' first set of requests for production of documents.
4. Plaintiffs have until **February 5, 2020** to serve any additional written jurisdictional discovery requests pursuant to Federal Rules of Civil Procedure 33, 24, or 36. The Expedia Entities and Booking Entities have until **February 21, 2020** to file any objections to the additional written jurisdictional discovery propounded.
5. Plaintiffs have until **February 25, 2020** to contact Magistrate Judge Jonathan Goodman to make arrangements to appear at his next available discovery calendar to address any objections by Defendants to Plaintiffs' additional written jurisdictional discovery.
6. The Expedia Entities and Booking Entities have until **March 5, 2020** to respond to any additional written jurisdictional discovery requests still pending, including the production of documents responsive to requests for production.
7. The parties have until **March 20, 2020** to complete jurisdictional discovery, including Rule 30(b)(6) depositions on topics relating to personal jurisdiction.
8. Plaintiffs have until **March 27, 2020** to file their final amended complaint or file notice that they intend to proceed with the Second Amended Class Action Complaint [ECF No. 63].
9. The Expedia Entities and Booking Entities have until **April 10, 2020** to file a renewed motion to dismiss for lack of personal jurisdiction.

10. The deadlines contained in the Scheduling Order [ECF No. 71] are set aside. A revised scheduling order will be entered after April 10, 2020.
